### According to Section G7 (a) Base Rate

- a.) Standard Meter Base Rate (5/8" x 3/4" Meter) 2,000 Gal. Allowed \$58.95
- b.) Non-Standard Base Rate (3/4" Meter) 4,500 Gal. Allowed \$88.28
- c.) Non-Standard Base Rate (1" Meter) 7,500 Gal. Allowed \$147.13
- d.) Non-Standard Base Rate (1 1/2" Meter) 15,000 Gal. Allowed \$294.26
- e.) Non-Standard Base Rate (2" Meter) 24,000 Gal. Allowed \$470.82
