ADDENDA #11 TO TARIFF

Section E. 28. Member's Responsibility e.) (page 29):

Change Entire Paragraph From:

The Corporation shall require each Member to have a cut-off valve within two feet of the meter on the Member's side of the meter for purposes of isolating the Member's service pipeline and plumbing facilities from the Corporation's water pressure. The valve shall meet AWWA standards (a ball valve is preferred). The Member's use of the Corporation's curb stop or other similar valve for such purposes is prohibited. Any damage to the Corporation's equipment shall be subject to service charges. (This cut-off valve may be installed as a part of the original meter installation by the corporation.)

Change Entire Paragraph To:

The Corporation shall require each Member to have a cut-off valve on the Members' side of the meter box as close as physically possible to the meter box, but no closer than 24" from the meter box for the purposes of isolating the Member's service pipeline and plumbing facilities from the Corporation's water pressure. As a condition of receiving water service, all new accounts must have this cut-off valve installed before the Customer Service Inspection (CSI) is performed and passed or water service will not be activated. The above is also required anytime a CSI is triggered for the approved reasons. The Member's use of the Corporation's curb stop or other similar valve for such purposes is prohibited. Any damage to the Corporation's equipment shall be subject to service charges



ADDENDA #11 TO TARIFF

The Corporation shall require each Member to have a cut-off valve on the Members' side of the meter box as close as physically possible to the meter box, but no closer than 24" from the meter box for the purposes of isolating the Member's service pipeline and plumbing facilities from the Corporation's water pressure. As a condition of receiving water service, all new accounts must have this cut-off valve installed before the Customer Service Inspection (CSI) is performed and passed or water service will not be activated. The above is also required anytime a CSI is triggered for the approved reasons. The Member's use of the Corporation's curb stop or other similar valve for such purposes is prohibited. Any damage to the Corporation's equipment shall be subject to service charges
